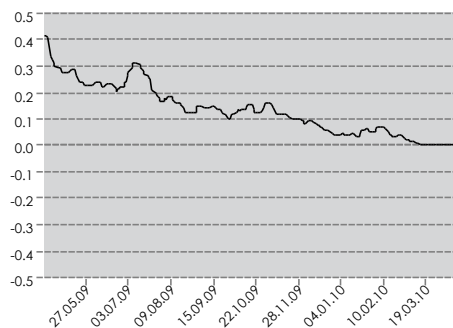

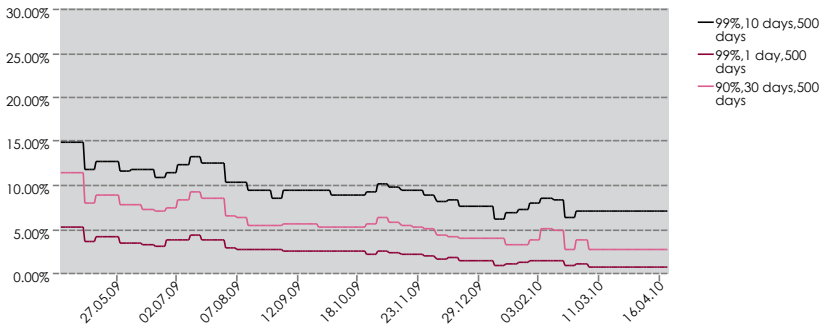
VaR over time

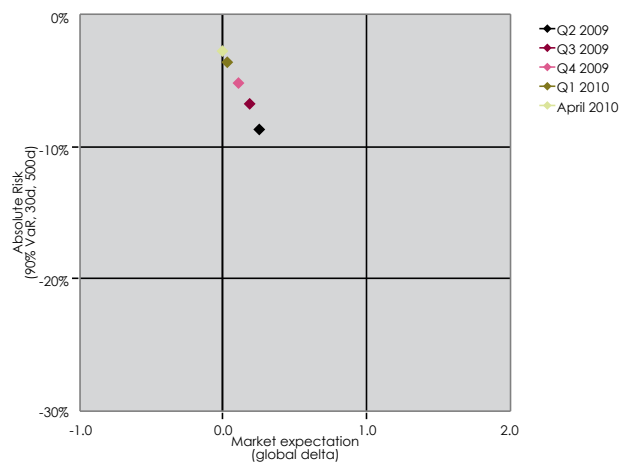
